Fees and Payment Information

What are the Fees?

Top of the World Ranch is a private facility. Our clients pay with cheque, credit card, or cash. Some clients arrange financing through a third party, Medicaid. In some cases, clients' treatment fees may be covered by their employers. It is the client's responsibility to arrange payment.

The cost for primary treatment, which includes all individual and group counselling, programming, psycho-educational sessions, family intensive programs, lodging, meals, and transportation to and from Canadian Rockies International Airport, is as follows:

30 days: \$16,950.00 plus 5% GST
45 days: \$23,750.00 plus 5% GST
60 days: \$29,950.00 plus 5% GST
90 days: \$41,950.00 plus 5% GST

The cost of the Detox Program for clients entering primary treatment is: \$650.00 per night plus 5% GST. The cost of the Detox Program for clients NOT entering primary treatment is: \$775.00 per night plus 5% GST.

The cost of primary treatment and Detox described above does NOT cover incidental services or products such as doctors' visits unrelated to addiction treatment, pharmaceutical prescriptions, massage therapy, acupuncture, Reiki, haircuts, Ranch store purchases, in-town purchases for items clients may have forgotten to bring such as clothing or cigarettes, or travel costs other than trips to and from Canadian Rockies International Airport. Clients who use these additional services will be invoiced on a bi-weekly basis.

When do I pay?

Prior to arrival, clients directly entering primary treatment must provide a signed Financial Agreement and pay a \$4000 non-refundable deposit. At day of arrival, clients pay the full the remaining balance for their primary treatment. Clients entering Detox prior to primary treatment will pay in full for primary treatment at arrival and pay for their total time in Detox their last day of Detox.

Detox-only clients must provide a signed Financial Agreement and pay a \$2000 non-refundable deposit prior to arrival and pay the remaining balance for their total time in Detox treatment the day of discharge.

At arrival, all clients will also make a pre-payment of \$750, which will be applied toward the above-mentioned incidental services or products. Any unused amount of the \$750 deposit at the end of stay

will be refunded. If expenses exceed \$750, the additional amount will be charged to the client credit card provided on the Financial Agreement.

What if I wish to extend my primary treatment?

Clients sometimes decide to extend their treatment. In such cases, the amount due to extend will be the total cost of treatment at the extended treatment program length, less what was already paid in full for the original treatment program length. Thus, by extending, the client in effect receives the lower daily rate of the longer program from day one. The exception to this is when a client is extending for just a few days, not for a full program extension. In these cases, the client will pay a daily rate of \$550 plus 5% GST.

What if I leave treatment before completing my program?

If a client chooses to leave treatment prior to the completion of their program OR a client is asked to leave treatment for not adhering to their treatment agreement, such as rule breaking and lack of participation, a prorated refund will be issued for the remainder of their stay, minus the non-refundable deposit of \$4,000 and a one-time \$650 empty room charge. Both of these are applied to the end of the stay, therefore no refund is provided for the last nine days of treatment. The refund is calculated beginning the day after discharge. If a medical discharge takes place, the client will receive a prorated refund for the remainder of their planned stay with us, less \$2,500 of the deposit.
